

CURRENT HEALTH GUIDELEINES

Daycare centres

Applicable from 24 August 2020

In the context of the COVID-19 health crisis, all of our childcare facilities are applying the measures and recommendations issued by the federal, cantonal and communal authorities. As a public company, it is our duty and responsibility to help prevent the spread of the epidemic together with all of the Swiss population.

We are happy to receive your children in our daycare facilities (EVE), but we are nevertheless bound by strict health guidelines that are changing our everyday childcare practices and contact with parents.

We would like to thank you in advance for adhering to these guidelines so that we can continue to operate in the best way possible during this unprecedented situation.

If there are any changes to the health guidelines and measures, the centre will inform you at the earliest opportunity.

HOW TO PROTECT OURSELVES



Keep a distance of 2m between all adults and no handshaking.

All adults and children over the age of 12 must wear a face mask when entering a childcare centre.

Adults must disinfect their hands with hydro-alcoholic gel upon entering the childcare centre. Children must wash their hands upon entering the main room.

DROPPING OFF AND COLLECTING

The drop-off and collection times remain unchanged.

For the Monthoux, Champs Fréchets, Parc and Vergers daycare centres:

Drop-off before 9.15 a.m. and collect from 4.15 p.m.

For the Cité daycare centre:

Drop-off in the morning before 9.00 a.m. and collect from 11.00 a.m. Drop-off in the afternoon before 3.00 p.m. and collect from 4.30 p.m.

These times are adjusted for children with special needs.

PARENT MEETINGS

Meetings must be organised in advance so that a meeting room can be provided that is able to accommodate the persons concerned.

Meetings must take account of the preventive measures, namely:

- ✓ Social distancing of 2m
- ✓ Washing or disinfecting hands on arrival and when leaving.
- ✓ Wearing a mask is compulsory

PERSONAL BELONGINGS

On a daily basis, children's personal belongings are limited to security blankets and dummies.

Where possible, you are advised not to store your pushchairs on site (including bikes, scooters, etc.) to avoid spreading the virus into the facilities provided for this purpose.

HEALTH

Illnesses and conditions requiring the exclusion of a child from the daycare centre are set out in the "Child health" booklet that was given to you. We encourage you to refer to it.

These measures are constantly changing with the COVID-19 situation and can be very restrictive. You will be immediately notified of any changes made.

Parents and adults with symptoms or who have been in contact with someone who has the virus are urged to respect the isolation and/or quarantine measures to prevent the spread of the virus. The same applies if you have stayed in an area with an increased risk of infection (refer to the list published by the Swiss Federal Office of Public Health [OFSP]). If any of these measures apply to you, you may not drop off or collect your child from the daycare centre.

Senior management reserves the right to apply regulatory measures for anyone who fails to comply with the guidelines in force.
